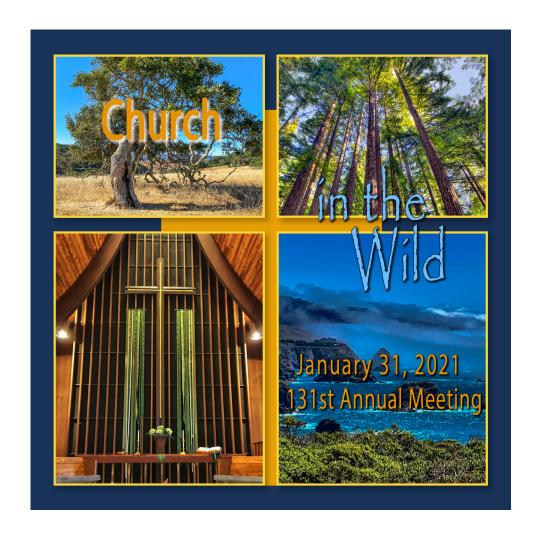

130TH ANNUAL MEETING MINUTES, COMMUNITY CHURCH OF SEBASTOPOL, JANUARY 26, 2020

The meeting was called to order by Moderator Mike Ott.

Pastor Lacey, Beth Larssen and youth group members opened with a prayer for our church.

Pastor Rachel read a poem by Mary Oliver and then the names of the people that passed away since the last annual meeting. A soft bell tone was rung after each name. Members at the meeting said names out loud of loved ones.

Denelle Tognozzi, church clerk, confirmed that there was 10% of our membership present for a quorum.

M/S/P Judy Hawkins/Judy Rice to approve the minutes of the 129th annual meeting.

M/S/P Marian McDonald/Beth Larssen to approve the minutes of the August 11th Special Congregational meeting.

Ministers' Updates

The Pastors shared notes on each other.

2019 Financial Report and 2020 Proposed Budget

John Henel reviewed the 2019 financial report and the proposed 2020 budget. He did a recap of 2019. We ended the year with a \$23,168.00 surplus. The detailed YTD report is included in the annual report.

He then presented the proposed budget for 2020. He thanked the Budget committee: Pastor Ben, Kathy Bell, Jennifer Halleck, Julie Reimer, Denelle Tognozzi and himself. The committee took in budget requests from the various committee and teams. The proposed budget has 5.5% increase in revenues and 10.1% increase in expenses. The proposed budget was presented to the Leadership Council at the January 15 meeting. The council voted unanimously to approve the 2020 budget to present to the congregation at the annual meeting. It was decided to use the 2019 surplus and reduce some of the requested amounts to balance the budget. There are several areas that have funds in restricted accounts and using those funds is encouraged. Using the surplus at yearend is not a sustainable practice. There is a 7% increase in operating pledges this year. There was discussion and questions from the congregation before the motion was made to approve.

M/S/P Jeff Boal/Ann Butterfield to approve the proposed 2020 Operating budget for the Community Church of Sebastopol.

Facilities Update

Larry Stallings reported on the three groups of the Facilities committee: Health & Safety, Grounds team and Facilities Team. There have been many improvements made throughout the campus. There are details in the Facilities report in the annual report. Some of the goals for the coming year are: Painting Fellowship Hall, repairing the retaining wall by Memorial Hall and repairing the courtyard between the sanctuary and Fellowship Hall.

Outreach Update

Joyce Cox reported on the many areas that our church supports our Wider Mission. At our church, we have bus passes, showers, safe parking, 2nd Saturday lunch and 32 AA groups. Many groups in Sonoma County benefit from funds from our church and volunteers. Joyce gave a detailed list of groups and services in the Annual Report.

LEAD MINISTER 2020 REPORT

REV. DR. BENJAMIN J. BROADBENT

"But to this day the Lord has not given you a mind to understand, or eyes to see, or ears to hear."

- Deuteronomy 29.4

A year ago, we entered a new decade. The number 2020 holds the resonance of clear vision. As a congregation, we held out hope for newness in our church and the wider world. And then multiple crises emerged all at once: a crisis of leadership, a global pandemic, an economic collapse, systemic racism in the form of police brutality, and environmental catastrophe. Last January, if we thought we had a clear vision of how 2020 would play out, we were wrong.

The Bible reminds us that our ancestors in the faith often got it wrong, did not have "a mind to understand, or eyes to see, or ears to hear." The question for them, and for us, is not "How do we see clearly to avoid hardship?" but "How do we use hardship to see more clearly?" There are now things we see more clearly than we did a year ago. Presidential leadership is as corrupt as we feared. Hyper-individualism does not allow us to care for the common good. Disparities in our economy are not accidental. Racism is a core aspect of American identity. Our planet cannot sustain life if we continue exploiting its resources.

What is most essential has remained intact: God's stead-fast justice, love, and mercy. Throughout 2020, our congregation responded and adjusted. Sometimes we were graceful and adept, and sometimes not so much. We found new ways to connect and communicate. We learned new skills, forged new friendships, discovered new vulnerabilities. If "hindsight is 20/20," here are the hindsights I'd like to highlight:

- January 12 On Baptism of Christ Sunday, Destiny Stone and son Liam were baptized.
- January 26 Melody Anderson and Destiny Stone joined the church, our only two new members this year. Thank you, God.

- February 23 Margot and Emerson Dowdney were baptized.
- March 1 The season of Lent began with the theme "Lent is a Time to Fast."
- March 15 At the outset of pandemic, ministers and choir videoed a worship service in the sanctuary to share with the congregation online.
- March 22 While sheltering-in-place, YouTube worship playlists were created, a format that lasted through mid-August.
- In April, Becca Emerson trained Chris Chang Weeks to become our new Congregational Administrator. The Emerson family moved to Oregon.
- May 31 Summer worship began with the theme, "Stewards of Incarnation."
- During the summer, Keyboardist J. Althea began recording hymns with the voices of one or more choir members to be shared in online worship.
- Handbell Director Karna Roa learned how to record handbell pieces while remaining socially distant, including involving former church member, Hollace Vaughn, who participated from Washington state. Harpist Laura Simpson was featured on many pieces, as well as "Benji the cat." While recording in Ragle Ranch Park, passersby would often stop to listen, and some even shed tears.
- July 22 Pastor Lacey and I began leading the Leadership Council in a 2-month Anti-Racism discussion using Ibram Kendi's "How to Be an Antiracist." Following the study, Moderator Mike Ott adopted the practice of asking "How does our decision promote equity?" during Council meetings.
- August 11 Dr. Sharon Fennema began leading a 4-session anti-racism workshop with the pastors and music staff called "Worship as White Space."
- August 30 Changing worship format, we began worship via Zoom, livestreaming to Facebook and

posting the video on YouTube.

- September 13 On Launch Sunday, we begin a new ministry program year with a theme coined by Pastor Rachel, "Church in the Wild."
- October 4 We kicked off our 2021 pledge drive with the goals of gathering pledges from 150 households totalling \$375,000 toward Local Church Ministry and \$39,000 toward Wider Mission.
- October 25 Rev. Brian Plaugher helped lead worship on his last Sunday as Minister of Music.
- November 1 On All Saints/Souls Sunday, we remembered the names of beloved ones we have lost. Church members who died in 2020 were Prue Manley (May 17), Martha Rowlands (May 26), Sid

- Buchanan (November 4), Allen Sherman (November 14), and Nancy Mathews (November 23).
- November 30 Julie Reimer began training Deanna Euritt to replace her as our church's Bookkeeper because Julie and Russ moved to Denver.
- December The seasons of Advent and Christmas include candle-lighting liturgies created by Dr.
 Sharon Fennema and the theme, "Awaiting the Unexpected: Letters of Longing from the Wilderness."

Let us pray: God, in 2021, grant us minds to understand, eyes to see, and ears to hear so that we may receive your gifts, however unexpected, and so that we may learn to follow the prompting of your Holy Spirit to be Christ's body in the world. Amen.

ASSOCIATE MINISTER OF FAITH FORMATION 2020 REPORT

ear Beloved Church, as I write this report, Epiphany—our season of sacred journey, purpose, revelation, and testimony—has just begun. This past year has come with tremendous collective experiences of grief as the safety and wellbeing of our communities has required us to stay physically distant. And yet, it was also a year of inspiring, creative resiliency and tender community care. Looking back over our ministry together in 2020, it strikes me that it was only seven months into our time together that COVID and shelter-in-place orders changed our lives forever. As of October 2020, I have officially been serving as one of your pastors longer in the midst of a global pandemic and as a virtual church, than in person. I am grateful, humbled, honored to be here with you, in all of the mess, uncertainties, questions, and possibilities that this wilderness holds for us.

When I consider what forms us as Christians, I am reminded that one of the only rituals or prayers that we practice weekly, across most denominations, is the practice of saying the Lord's Prayer. It is often one of the only prayers people know by heart, even folks who are not currently part of a Christian community. This practice of repetition invites the prayer to become part of our body and our movements, our spirit and our breath. In

so doing, the Lord's Prayer is forming us. This year, in the face of pandemics of COVID, racism and political unrest, to say, "on earth as it is in heaven," feels like an epiphany prayer. It is a prayer that is testifying to our calling, a prayer that manifests our potential as a people and a world. This prayer that calls us and forms us to create God's kindom on earth is one that I have been dwelling with deeply as we have re-imagined our faith formation ministries, indeed all of our ministries, to meet the complex realities of our lives today. Below are some of the ways this prayer has formed my ministry at Community Church in 2020 and in the days to come.

In the Mission and Outreach Team we began to give voice to the greater impacts we hope to have with our ministries. We started this process by reflecting on who our various outreach ministries serve, what we understand to be the underlying values/commitments to justice that motivates our participation in this ministries, and then we creatively imagined how we would continue to serve these people, or embody these values/commitments if we did not have any money or resources to give. Out of these discussions emerged our weekly Advent Reflections and Faith-in-Action Practic-

es, that invited people to engage more fully – through prayer, art, education, service – with the Sam Jones Christmas Bag (shoebox) Ministry.

Our church's leadership, including staff and council, began the challenge of uncovering how white supremacy and understandings of race have formed us. Through a four-week long workshop led by Dr. Sharon R. Fennema from Pacific School of Religion, the worship staff began discussing how our worship is formed by whiteness, as well as tactics to help us create greater equity in and through worship. Leadership Council met weekly for two months to read and discuss Ibram X. Kendi's book, How to Be An AntiRacist. From this reading, council committed to asking this formational question of every agenda item: "How does this promote greater equity?" This question proved especially important as we discerned how to create the 2021 budget while uncertain about the impacts of COVID on the financial wellbeing of our community. One formational tool that emerged from this process was the invitation for every ministry team to engage with the following questions as they put together their budget requests:

"What are your hopes for your ministry area?" As you move through each line of your budget: "How does this decrease or increase in funds requested promote greater equity? How does this decrease or increase in funds requested help us live into our church's mission to, 'put our faith into action'?" and "What story does your budget tell?"

With our youth groups we identified four faith formation pillars that guide our time together each month: Scripture/Story, Play, Justice and Service. When we meet we take time to check in and share a bit about our lives, be in ritual and prayer together, and then engage with one of these pillars. Despite Zoom fatigue from being full-time virtual students, middle and high school youth groups have seen an increase in regular participation, as members continued to show up and enthusiastically gather for weekly Zoom youth groups. High School youth group went from meeting twice a month when we could gather in person, to meeting every Sunday. Although Service and Learning Together (SALT) Trips were canceled, youth groups engaged in local, COVID-safe service opportunities, including food drives, harvesting

produce for food boxes at Garth Watson's community garden, and a land-care project in Ragle Ranch. While youth were not able to attend camp at Caz, they were invited to participate in a virtual Talent No Talent Night led by Kathy Bell and Brian Wetzel.

Recognizing that many of our families with young children were overwhelmed by the amount of screen time required of their children now, the Children's Faith Formation Action Team began putting together and delivering monthly Wilderness Kits to families. Each month's kit revolved around a scripture story and provided simple materials to help enliven the story and deepen their faith lives through art and prayer. In September we also began hosting monthly Movement Time for children K-5 on Zoom. These gatherings are 15 minutes long and like the kits, help connect the children to scripture through movement and music while also providing a playful place to be with their peers from church.

This year's Adult Formation ministries saw several wonderful staff and lay-led opportunities, including book groups, spiritual practice groups and Sunday Bible study. I am excited to continue expanding the reach of Adult Faith Formation with new writing and prayer groups in the coming year and greatly welcome all ideas and offerings to share.

In October, I co-facilitated, along with Larell Fineren, our church's first Safe Church Training for volunteers who work with vulnerable members of our community (including minors and vulnerable adults). This training focuses on three core elements:

- Understanding Power Dynamics
- Cultivating a Culture of Consent
- Developing Practices for Clear, Open Communication.

We are eager to incorporate these elements more fully into the formational work of our entire congregation.

At the dawn of this new year, in this extraordinary time of epiphany, may we know in our bodies, relationships, thoughts, movements, and ministries the prayer, "Your kindom come, your will be done, on earth as it is in heaven." May these words inspire us and form us as we co-create a new world.

ASSOCIATE MINISTER OF CONGREGATIONAL CARE 2020 REPORT

It has been my deep privilege to offer leadership and care as Associate Minister of Congregational Care in 2020. In a literal sense, the word "apocalypse" means "take the lid off" or "unveil." As the year progressed, 2020 took the lid off a series of such revelations: pandemic, racist violence and systemic racism, climate-induced wildfires, and a heated election season. Our wider culture found new words to describe our lives: "social distancing," "doomscrolling," and "blursday." And our church community founded new programs to support our spiritual and community lives: "Congregational Life Team," "Noonday Prayer," "Church in the Wild," and "Zoombassadors."

Even in the midst of disorientation, I witnessed our church community seeking out and creating hope, joy, kindness, and love. Gladys Chappell, one of our members in an assisted living home, inspired our church's boulevard sign: "There is no place you can go where God is not." Those became our words of assurance as we sheltered in place, along with "The building is closed, but the church is open." As the year unfolded, I was honored to walk alongside those in need of spiritual care, as well as many who wanted to be in service to others. I repeatedly found myself so grateful to be part of a staff team and congregation that worked so hard to meet the challenges of the year with thoughtfulness and heart.

And, I was grateful to receive a six-week sabbatical, in celebration of 5 years of ministry with our congregation. During my sabbatical, I engaged in a study of dying, death, and grief-- and got good sleep, hiked, cooked, and enjoyed my family. I am grateful to those who stepped into leadership to cover ministries in my absence. And I look forward to the blessings and challenges of our church's (and our world's) re-orientation in 2021.

In 2020, Ministry continued, even with virtual constraints:

- ♦ Pastoral care and counseling by phone and video calls
- ♦ Home visits, limited, outdoors with mask and face shield

- ♦ Delivery of prayer shawls, outdoors with socially distanced blessing
- Memorial services shifted to prayerful remembrances emailed to the congregation
- ♦ Leadership and support to ministry teams: Visitation, Prayer Shawl Ministry, Kindred Groups, Women's Fellowship Card-Writing
- ♦ Leadership Council meetings
- ♦ Partnership with Council Member for Care & Fellowship
- Worship leadership for pre-recorded and zoom
 Worship services (pastoral prayers, some preaching)
- ♦ Weekly prayer concerns published in emails
- Collaboration and camaraderie with clergy colleagues
- ♦ Kindred Groups supported those experiencing loss and illness

New Ministries emerged:

- Pastoral phone calls to church members in first weeks of shelter-in-place
- Noonday Prayer, weekly online prayer gathering
- Congregational Life Team: I recruited and provided leadership to this new team, which is dedicated to relationship-building and connection during the pandemic. Some projects initiated by the CLTeam:
- Games Nights (online)
- Walk on the Wild Side (solo walking journey through the church campus during Advent)
- Book Discussions (online)
- Wine Tasting (online)
- Blessing of the Animals (in Zoom Worship)
- Anam Cara "Soul Friend" phone calls with elders who live alone
- Special Election Prayer Vigils
- In-Person Prayerful Gatherings
- Curated resources for social-emotional health in these pandemic times
- Pastoral phone calls to church members impacted by wildfire

2020 MODERATOR REPORT

MICHEAL OTT, MODERATOR

n March 18, the Leadership Council met – on Zoom! – as the COVID-19 pandemic caused our church buildings and campus to close and forced us to adapt to the reality of shelter-in-place. We discussed how and in what ways we could lead the congregation through this difficult time. We knew we wanted to stay in touch with all congregation members, opening communication in new ways, gathering information and listening to concerns, to continue to build community. The buildings may have been closed but our church, an open and affirming church, was going to need to be open more than ever before. The Council was in agreement that for every circumstance we could rely on our Mission as a guide. "To worship God and share the love of Jesus Christ, teaching the message of Jesus to all ages and putting our faith into action." Our task was to provide new ways to worship, love, teach and act as we journeyed through what turned out to be a year of troubled times.

Over the weeks and months, programs and events were created and set into motion so we could fulfill the need and desire for all of us to come together in many ways. We expanded our capacity to meet the needs of the congregation by learning new skills to provide information, updates and spiritual nourishment. Our church provided opportunities for alternative ways to pray, meditate,

praise and worship. Pastor Lacey phrased it as "new ways to see the Divine." We developed new, different and enhanced ways to connect as a congregation and to share and sustain God's presence by listening to each other's longings and holding those who felt left out due to a technology gap that separated them from our ministry programs.

Many beautiful things developed and took root over our pandemic sheltering. We revisited core values that our church family has always held. During the summer as we hoped for a safe return to the physical church, we placed the values of honoring safety, centering the vulnerable, maintaining transparency and setting appropriate boundaries for caring and communicating above a rush towards a quick return to church as we have known it. Our desire was that deeper work on these core values would result in a stronger, more compassionate and grace-filled church community for when we could return to church in body as well as spirit.

Our church embraced these values as we traveled through summer and fall. We worked towards bringing outward witness to equal justice through anti-racism book studies and discussion groups. The Outreach Committee created and fulfilled a vision of an advent ministry that included education about homelessness,

to emphasize a desire to promote greater equity in the world. The Congregational Life Team brought chances for connection with each other with the goal of maintaining a spirit of wholeness. Our theme of "Church in the Wild" provided us an opportunity to grow our faith - not alone, but together in new and different ways

FACILITIES RESOURCE AREA 2020 REPORT

WORSHIP & ARTS MINISTRY AREA 2020 REPORT

LINDA ROA, COUNCIL MEMBER FOR WORSHIP AND ARTS

The Worship and Arts Ministry area includes commit-L tees, teams and volunteers who coordinate worship, music and other "behind the scenes" areas at Community Church. It involves many different aspects in putting together Sunday worship. We began 2020 with full teams; however, this year with the onset of COVID-19, many aspects of this area were not necessary as we moved on to Zoom meetings (i.e. ushers, communion servers, regular weekly flower arrangers, etc). Other areas had to re-invent themselves to accommodate the new situation, specifically, the worship service itself which put a lot more pressure on the ministers to re-create the new "virtual" service. The music area changed as the choir and handbell ensemble could no longer gather and handbells became more creative; the keyboardist assumed a bigger role to prepare vocal and keyboard pieces; and liturgists had to learn a new way to spread the Word.

WORSHIP PLANNING TEAM

Rev. Benjamin Broadbent, Lead Minister

This team gathers quarterly to do mid-range planning of our Sunday morning worship. We met on January 16, 2020 to plan the seasons of Lent and Easter. The pandemic hit the third week in Lent and our theme, "Lent is a time to..." took on a whole new meaning. Adjusting to the new circumstances, we shifted toward doing weekly planning via Zoom. We began our new reality by videoing an entire Sunday morning worship in the sanctuary

with no congregation, only worship leaders including a choir. By the following week, we were creating playlists on our church's new YouTube channel. In late August, we shifted to worship on Zoom and are still working with that format.

Our musicians had to adapt to the new circumstances. Our Minister of Music, Rev. Brian Plaugher, began weekly online meetings with the choir to build community even though the choir couldn't sing together. Our Keyboardist, J. Althea, pulled together soloists and small ensembles to record hymns for use online. Our Handbell Director, Karna Roa, began by recording Handbell solos and eventually found ways to record the Handbell Ensemble while practicing safe distancing.

Our pastors adapted to the new circumstances. Pastor Lacey found ways to engage with young people (and older people) through online Children's Messages. Pastor Rachel found ways to create pastoral prayers that conveyed God's care even while we were isolated from each other. Sermons became video productions as well as theological messages. Internet bandwidth became a new form of daily bread.

The chair of our Sanctuary Arts Team, Kathy Matthies, continued to change out the colors of the sanctuary, caring for our sacred space so that the images of the sanctuary would follow the liturgical season even

through videos. Our Liturgist Coordinator, Judy Rice, continued to recruit liturgists even though some found it difficult to say yes to the new format. Our Communion Coordinator, Joanne Matson, set the sanctuary table and provided a beautiful communion set from her Catholic Worker days.

For the fall, we adopted the theme of "Church in the Wild," originally Pastor Rachel's idea. At the end of October, Rev. Brian Plaugher left his position after over 15 years as our Chancel Choir Director/Music Director/Minister of Music. We began the liturgical year anew at the end of November with the Advent theme of "Awaiting the Unexpected: Letters of Longing from the Wilderness," conceived of by Sharon Fennema who also created candle-lighting liturgies for the season.

It's been a long, strange year, but we've learned some new skills and a lot about ourselves and our community. Thank you to all church members who have had a hand in planning and leading worship in 2020.

LITURGIST PROGRAM

Covid restrictions temporarily put a halt to our liturgist participation program as we faced shelter-in-place restrictions in March. When we did resume services via Zoom, we found ourselves facing technical stumbling blocks and a whole new set of protocols. Initially, many people chose not to participate in this new format with its unique set of challenges. As we all became more familiar with this new way of worshiping together, volunteers began to step forward to help lead our services as "online liturgists." We now have an increasing number of our congregation members who are taking on this role, including many younger participants. With a hope that we can increase our numbers, we look forward to the coming year as we find our way out of the wilderness.

SANCTUARY ARTS/FLOWER TEAM

The committee purchased a minimal supply of dried and silk flowers to enhance the altar for the times when broadcasting from the sanctuary. We long for the day when we can all be together once again and beautify our church once again.

MUSIC MINISTRY

Most of the time, the production of an annual report on music at the church is a recitation of stability. We have usually gone along mostly as we have before. For a few months in 2020, the music program worked as it has in the past, with a variety of performers in a variety of ensembles. J. Althea ably accompanied them, as well as congregational singing and other worship music. The choir sang, and the bells rang. We even had a special concert to celebrate the refurbishment of the grand piano in the sanctuary.

Then, everything fell apart. As the pieces got put back together, we learned how to do worship on line, at first with all the elements recorded, and more recently with a streaming service with the music still recorded. The handbell ensemble and chancel choir transformed their rehearsal times into Zoom meetings for emotional and spiritual support.

At the end of October, our Minister of Music for the last 15 years, Brian Plaugher, left for a new ministry at Spring Lake Village. He misses you all very much, but is confident that whatever changes are in store, even the change back to what we used to call "normal", will be handled with aplomb. If we can get through 2020, musically and in all other ways, this congregation will no doubt navigate whatever comes along in 2021

FAITH FORMATION MINISTRY AREA 2020 REPORT

aith Formation in 2020 rose to the challenges of our pandemic times. to manage ongoing activities, studies and special events. Kendall Tripathi-Clark began the year as our Council Member for Faith Formation, and I would like to thank her for staying the course through the early transition to "COVID times". At midyear I took over from Kendall, working closely with Pastor Lacey to learn the ropes of faith formation ministry. What I discovered was a group of dedicated adults who have continued to encourage and educate our school-age members during these challenging times. In addition to their ministry, other faith leaders have been able to lend continuity to our adult Bible study groups. New in 2020, and in light of the national conversation on racism and protests following George Floyd's death, we offered two book discussion groups centered on antiracism. These book studies will continue into 2021. We see self-awareness through education as an important first step to becoming an antiracist church. We also held two Safe Church workshops targeted to adults who work with vulnerable members--both children and adults. Believing that a safe church environment is every member's responsibility, we will offer additional trainings in 2021 to reach a greater number of our members.

Childrens' Faith Formation Team (ChilFFAT)

This year ChilFFAT walked through the wilderness along side every other church team, and would like to commend Pastor Lacey for her EXTREME leadership during this wilderness walk. Beginning with Holy Week through Easter we had a weekly Godly Play presentation available in a playlist at Community Church YouTube; followed through May by a life application of Scripture. In developing our "Church in the Wild" theme, ChilFFAT has met monthly on Zoom to brainstorm wilderness bag content. As a team we have continued to put these bags together and deliver them to 30 families with children. These wilderness bags are coordinated with a monthly Godly Play video, which may be viewed in our church's playlist on YouTube. We have also offered a 15 minute time, once-a-month, following Sunday service, for children to be involved in music and movement on Zoom. I must end this blurb by saying what a pleasure it has been to work with, and be a part of my Community Church in these unprecedented times.

Our Whole Lives--Sexuality and our Faith

The Our whole Lives (OWL) program had a quiet year. Before the shelter-in-place order, the Steering Team was able to send one person, Mike Ott, to an out-of-state training to be an OWL facilitator for the

elementary level. He described the experience as life-changing. The 8th-9th grade level OWL is scheduled to take place during the 2020-2021 program year. Due to the pandemic meeting restriction, this has not yet happened. The people who oversee the Our Whole Lives program at the national level, though, have created modified curriculum that could be delivered virtually. Our team is in discernment as to whether this may be an option for our community.

Youth Ministry Team

It is a profound pleasure to watch how the 6th graders tentatively enter the youth program and grow to trust the group of teens. They gain confidence in each other through our weekly "check in" around the circle. (A 'check in' is to name a 'high' and a 'low' from the previous week.) They gain confidence because they can choose to confide in each other as it becomes comfortable. These young people are deeply thoughtful, discuss scripture with discernment, show empathy, value social justice work and just plain have fun together. I am so glad to be a leader of the Mid High and Senior High youth groups.

Adult Bible Study (Sundays at 9:15-10:15AM)

Gail Thomas, Coordinator

This is a Bible discussion group focusing on Biblical perspectives as they relate to our modern world and allowing a discussion of ideas and a 'give and take' among the participants. We value a range of opinions and find that a wide-ranging discussion and application to our world, current events and situation allows all of us to reconsider the relevance of our faith as we navigate these challenging times. We are 'in conversation with the Bible' as we engage in Gospel-guided conversations. We encourage people to join with us—the more perspectives, the livelier the conversation.

The Bible Study link appears in the same email giving the link for the Sunday service. The zoom opens

at 9:00 a.m. for those wanting to check-in, or 'see' each other, and talk before we start at 9:15 a.m. The Bible passage under discussion each week is listed in the general church announcement and is usually the same passage as being used for the church service and sermon. We end promptly at 10:15 a.m. to attend the zoom church service.

Women's Bible Study (Wednesdays, 10:00 to 11:30 a.m.)

Joanne Matson, Facilitator

We have two sessions of 10 weeks, in the winter and the fall. Our general study includes both the Old and New Testament, the extra canonical books, and resource material from scripture scholars, theologians and professors of scripture. We study historical context, cultural background and political settings—attentive to how the original audience heard and understood the Word. Through our study, sharing, and discussion, we continually find new meaning in Scripture enabling us to apply it to contemporary issues and our individual lives.

This past year, due to COVID, our winter session was cut short, having only four meetings. We considered the topics of Lamentation as an act of Faith; Struggle; Journeying toward Trust; and the cycle of Orientation-Disorientation-Reorientation. During the Fall session, we were able to meet in the Fountain Courtyard from September 9th to November 11th. We studied the concept of Biblical Faith, using texts from the Prophet Hosea, Book of Judges, The Moses Story and the Psalms. During this period, we had three contemplative bible studies, praying the scriptures together using passages that were especially meaningful to the individual participants.

In this year of Pandemic, both money and ability to carry out some of our normal outreach projects has been limited, but the Outreach Committee has continued Zoom meetings and was able to organize and carry out our Christmas outreach ministries. The Food Pantry, Safe Parking Program and 2nd Saturday lunch programs have fortunately been able to continue. Here are the reports of the various Outreach Groups of the church. A big thanks to everyone who participated in these projects!

Outreach Committee

The Outreach Committee received feedback about our 2019 shoebox ministry gift, the 104 boxes that were delivered to Sam Jones Mission. We were told that most of the items in the shoebox were appropriate and that additions to the shoeboxes such as playing cards, and brushes for women were welcome. They also requested warm gloves and games which sparked our idea for a Valentine's themed Games and Gloves Drive which turned out to be popular and successful thanks to the congregation's enthusiastic participation.

In March, the Committee organized and prepared to launch March Meatball Mania. The plan was to get donations of 360 meatballs and 360 cookies from the congregation to feed the Sam Jones Shelter residents for one night. Then COVID arrived and this outreach

was put on hold, hopefully to be revived in 2021.

The Outreach Committee reconvened in August to begin planning our Shoebox Ministry. Pastor Lacey joined us and we brought forth a vision of a shoebox ministry that would include education about homelessness. We would invite the congregation to ponder questions about people's need for the items in the shoebox and what our houseless neighbors' lives are like. We suggested bringing forth stories of similar struggles from the bible and tying this discussion and education about homelessness into the church's Advent theme for this year.

The shoeboxes we have always used were unavailable this year. It was decided that decorated brown grocery bags and recycled gift bags would make a great substitute. As we went forward with planning, we agreed that we wanted to emphasize a desire to promote greater equity in the world by putting our and the congregation's faith into action.

The Outreach Team, in collaboration with Faith Formation ministries and with the help of Pastor Lacey, completed a series of Advent reflections to accompany us in this important ministry. These reflections were sent to the congregation and friends of the church every Sunday night during Advent. This Advent practice email included meditations about houselessness in biblical and modern times along with a weekly faith in action practice. The emails encouraged the congregation to decorate a shopping bag or gift bag and fill it with the essential items needed by our neighbors at Sam Jones Mission. We collected the bags by sponsoring a drive through drop-off of the gifts in the church parking lot several times over the Advent season. The ministry was a success and Outreach delivered 168 bags to Sam Jones Hall just before Christmas.

We made Alternative Gift Catalogs available to

the congregation and \$2,796 in alternative gifts were given to help those in need around the world.

The Outreach Committee continued to pursue the idea of constructing one or two Conestoga Huts – micro-shelters for couples or individuals – in our church parking lot. We met with the City of Sebastopol in early December and received good feedback and positive response. The Committee is working on applying for a temporary use permit for the proposal with the hope that we might be able to fund and construct these huts in the spring or summer of 2021.

The Committee worked with the Safe Parking team to allow our safe parking folks occasional use of the Fellowship Hall kitchen. We continue to discuss other opportunities to address needs that our parkers may have.

The Committee assisted Rotary Club Sunrise by delivering Christmas Dinner boxes to people in our congregation on Christmas Eve.

Due to COVID and subsequent budget issues, the Outreach Committee had no money to fund organizations that normally come from the congregation's pledged Mission Giving. This pledged giving instead went to priority items such as the inter-faith food pantry and Our Church's Wider Mission (OCWM).

Saturday Table

Saturday Table is an ongoing ministry of five area churches: Sebastopol United Methodist, Sebastopol Christian, St. Stephen's Episcopal, Occidental Laguna Sangha and Community Church of Sebastopol. Each congregation commits to a specific Saturday each month, providing a noon meal to those in need of food and fellowship. Our guests include seniors, homeless persons, our "safe parkers", backpackers. All are welcome. The usual fare has been a home-cooked hot lunch contributed by members of our own community.

Since the COVID restrictions, the platform has changed temporarily. Our team prepares snack bags and we purchase Taco Bell gift cards which we distribute to guests in the Bell Courtyard. While not the same as the social atmosphere of the sit-down meal, we are still able to keep in touch with folks and provide the resources for a hot lunch.

Our team would like to acknowledge the past contribution of Sophie Sherman who passed away recently. Sophie loved cooking and prepared many special dishes for Saturday Table guests. We miss both her humor and her creativity!

The Sebastopol Interchurch Food Pantry

The Sebastopol Interchurch Food Pantry is a 501 (c)3 organization founded many years ago to supply food for anyone in need in West County. No ID is required to receive food, and clients may come once every 15 days. Food is allotted according to the size of the family. More protein has been added to the orders. The Pantry is open MWFS from 10-12 a.m. It is sustained by a dedicated group of volunteers: buyers, stockers, packers, cleaners, people who distribute at the window, the phoners who make sure that the staff is available, and of course the Board of Directors.

There have been some changes this year because of the COVID pandemic. There is hand sanitizer everywhere you look! There are now only two people distributing food instead of three to improve social distancing. On Wednesday there are three because it is exceptionally busy. The orders are being pre-packed to facilitate rapid filling of orders so people will not be standing in line. We insist that our clients comply with the COVID protocol. The Pantry is funded through donations from area churches, by special donations, and we receive wonderful support from area realtors and the USPS who have food drives that supplement our inventory and bring in some special things which we don't ordinarily buy. We also receive much wonderful produce from members of our churches, so thanks to you all. Note: This year our Food Pantry received a grant of \$1,200 from Alternative Gifts International to help during the Covid crisis.

Safe Parking Program

The Community Church in conjunction with the First United Methodist Church of Santa Rosa, Catholic Charities, and the County of Sonoma provides five parking spaces for individuals and families that have no other safe alternatives to spend the night. The allocated spaces are occupied from approximately 8:00 p.m. to 8:00 a.m.

Individuals wishing to find safe parking go through an intake process with Catholic Charities. They are referred to the First United Methodist Church which then inquires whether we have space. If the answer is yes, we then meet with the potential parker and if accepted, we notify the relevant parties. At night, Safe Parkers place an authorization notice on one of their car windows.

Community Church volunteers provide monitoring of the site to make sure the parkers are safe by driving through the parking lot one time during the night and if possible, in the morning. Volunteers are on call if there are any issues. Any calls from parkers are routed through a Google Voice number.

Shower Program

The church normally provides a shower program to serve a portion of our community's homeless population, 3 days a week. This program was suspended in March with the COVID restrictions. Showers are still available for the participants of our Safe Parking program. A big thanks to Roger Wilson and Larry Stallings for washing all the towels!

We also usually provide bus passes, snacks and clothing through the church office. These services are on hold because the office is closed at this time. Joyce Cox, Chair

The purpose of this group is to serve as a link between the North Bay Organizing Project and the Community Church. The Organizing Project focuses currently on three main areas:

- Roots (environmental projects)
- ► Roof (housing issues)
- Refuge (Immigration Issues).

Our goal this year was to provide educational programs for the congregation on each of these issues. In February we held the first program on the Environment, then COVID restrictions went into effect and we have not pursued the other topics.

For the last few years, our church has been heavily involved in immigration Issues through NBOP. Members of our church and the wider community formed the West County Accompaniment Team. We worked closely with a family from Honduras who was seeking asylum in the United States. Last December, the mother and three children were granted asylum. It was a fabulous day! We are happy to report that the family is now buying a mobile home in Indiana and as it has been a year since they received asylum, they are able to apply for residency. Peggy Porter and Joyce Cox tutored the children last spring and over the summer via Google Duo. Thanks to everyone who helped give them a good start.

Adult Mission Trip

FINANCE RESOURCE AREA 2020 REPORT

JOHN HENEL, COUNCIL OFFICER FOR FINANCE (TREASURER)

First of all, I would like to express my thanks to all who served on committees and teams that assisted in the Finance Resource Area (see names below). Your work is appreciated.

The story of the year is Covid-19, and its impact on so many families in so many ways. Church finances were indeed affected as well. While fulfillment of pledges remained as solid as ever, other revenue especially from facility use dropped precipitously. Applying for and receiving a forgivable loan for \$43,753 from the government in the Paycheck Protection Plan (PPP) was critical for us to keep all our staff intact.

Despite the significant challenges of 2020, the state of finance for the church is still very strong. Complete details of all financial data can be found elsewhere in the Annual Report. Here are a few highlights:

- * 2020 ended with a zero balance in the Operating Fund, as planned. While some Reserves, as authorized as part of the 2020 Budget, were needed to achieve the zero balance, an amount less than authorized was required.
- * The PPP loan was forgiven.
- * At the end of 2020, we held approximately \$756,000 in Memorial & Endowment Funds. Read more in the Finance Committee report below.
- * We continue to have no debts.
- * Pledges, our primary source of Revenue for both local and wider church missions, remain fairly strong. Read more in the G&G report below.

Budget Team

This committee begins meeting in the Fall to produce the budget for the next year. Through Leadership Council representatives, all functional areas, program areas, and committees are solicited to provide input to the budget. Both Julie Reimer and Deanna Euritt participated from the Bookkeeper position.

Given the financial impacts of a closed campus for most of 2020 and into 2021, the 2021 budget presents huge challenges. While predicting when we may resume a more normal operation is unclear, given that vaccines are now available, there is a reasonable optimism that this "fever" will break in 2021. Based on guidance from Leadership Council on multiple occasions, as well as from general membership in a special budget session open to all, there is overwhelming support to keep all staff in place with no reduction in hours or pay. This will require tapping into Reserves and other savings to close the gap for 2021.

The Proposed 2021 Budget can be found in the last pages of this Annual Report.

Gratitude & Generosity Team (Stewardship)

The Gratitude and Generosity Team kicked off the Annual Pledge Drive on October 2, 2020 with a goal of collecting pledges from 150 households totaling \$375,000 toward Local Church Ministry and \$39,000 toward Wider Mission

Our theme was "Church in the Wild." In the absence of a chairperson, Rev. Benjamin Broadbent coordinated the work of the team. Destiny Stone, Karna Roa, and Chris Chang Weeks developed an original logo for the campaign. Bobbie Johanson and Terri Harper collated and delivered 250 personalized pledge packets. Garth Watson helped the team and the congregation connect our financial needs to the particularities of ministry during a pandemic. Kristen DelMonte coordinated church members to offer videoed Steward-

ship Moments for online worship. We celebrated the generosity of all who pledged on Gratitude Sunday, November 8. At the close of the campaign, we collected pledges from 133 households totaling \$346,597 toward local church ministry and \$32,733 toward Wider Mission.

In 2020, the Finance Committee expanded its responsibilities to include the work of Memorial & Endowment.

Despite the significant economic impacts from Covid-19 in 2020, investments were ironically little affected, and in fact continued growth, by the end of 2020. As such, we saw gains of \$84,000 in our M&E Funds to end 2020 with a combined balance of \$756,509.

During the year, a long-needed extensive update to the M&E Guidelines was produced by the committee and approved by Council in April. Though funds were available for grants, only one (perhaps a side effect of the Covid-19 restrictions all year) was applied for and granted, which supported our Handbell Choir program.
