January 30, 2022

Due to increasing virus case numbers the meeting was broadcast via Zoom. The meeting was called to order by Moderator Robert Curtis.

- M/P Robert Curtis to approve the Annual Meeting minutes of the 131th annual meeting.

Community Covenant Process: Pastor Rachel reported that Robert Curtis and Kathy Bell have been meeting with her to create a Community Behavioral Covenant. They got the idea from a book called "A Sure Foundation". This is a resource for healthy relationships between pastors and the congregation. They have been sifting thru examples from other churches around the country. One of the phrases that spoke to them is "As forgiven people, we will choose to forgive one another. In the spirit of Jesus, and with God's help, we will show respect and love in all we do as we journey together". They have a timeline that they are continuing to follow to complete the process. The timeline for this year is as follows: Spring 2022:

- Listening Circles and Drafts of a Community Behavioral covenant Summer 2022:
- A Living document approved by Leadership Council Summer/Fall 2022
- All groups in the church try out the Covenant and offer feedback to LC as needed

2021 Financial Report and 2022 Proposed Budget: John Henel reviewed the 2021 financial report and presented the proposed 2022 budget. He did a recap of 2021. We started and ended the year with a zero balance. We were able to do this by pulling from some of the Reserves allocated in the budget.

The 2022 proposed budget shows additional funds for 3 months sabbatical coverage. Pastor Rachel will assume Lead Minister duties while Pastor Ben is on Sabbatical leave. There are Restricted funds available for Worship/Arts and Faith Formation expenses. The budget will be balanced by using Restricted funds only as needed. There was limited discussion and questions answered. M/P Robert Curtis to approve the adoption of the 2022 proposed budget.

Andy DelMonte was mentioned for bringing back the Youth and Children's choirs for special appearances. The card writer's ministry and prayer shawl ministry were mentioned. The Facilities team was commended for their ongoing upkeep and gardening volunteer time. It was a special time for people to get acknowledged for their participation and contributions.

LEAD MINISTER 2022 REPORT Rev. Dr. Benjamin J. Broadbent

The one who was seated on the throne said, "See, I am making all things new," and, "Write this, for these words are trustworthy and true." - Revelation 21:5

Greek island of Patmos, had a mystical vision of Jesus the Christ seated on a heavenly throne. This was an incredible vision because Jesus of Nazareth was executed on a cross by the Romans. How could he be reigning from heaven if he died a disgraceful death on earth? Well, first of all, the resurrection event experienced by many followers changed a shameful death into a life-giving victory. Second, the early church glimpsed in Jesus' life, death, and resurrection that, rather than operating through military might and macho bravado, God revealed Godself in Jesus through sacrificial love and trusting vulnerability. Through Christ, God makes all things new, not by coercion from without, but through transformation from within.

As I reflect on the year 2022, I am grateful for the ways in which this congregation is growing in its capacity to love others as God loves all of us. These are some highlights that come to mind:

- January 23 We said goodbye to Rev. Lacey Hunter who began as our Associate Minister of Faith Formation in August 2019 and served most of her time with us during the Covid pandemic. Pastor Lacey brought to us a passion for justice, concern for the most vulnerable, and sensitivity to the beauty of language. She left to pursue a call to serve the First Congregational Church of Alameda, United Church of Christ, just a short bike ride away from her Oakland home.
- January 30 The congregation offered me a blessing as I began a 3-month sabbatical, February 1 –
 May 1. At the end of the worship service, I removed my stole and placed it on the shoulders of Rev. Rachel Knuth, who served as Acting Lead Minister while I was away.
- February 6 To begin my sabbatical, I attended the Western UCC Senior Ministers Retreat at the Jesuit Retreat Center in Lost Altos. Later in the month, I created a blog to share my writing: www.benjaminbroadbent.com.
- March 15 I began an online class led by Natalie Goldberg called "Writing Down the Bones." I continue
 to meet with an online writing group that came out of this class.
- April 23 At the close of my sabbatical, I flew to New Mexico to take a class called "Writing and Antiquity" at Ghost Ranch where painter Georgia O'Keefe lived much of her life.
- May 2 Returning from sabbatical, I heard from many people how appreciative they were of Pastor Rachel's leadership. I learned about the worship themes of Lent and Easter and the "Good Enough" discussion group.
- May 15 Moderator Bob Curtis led a post-sabbatical event which gave me an opportunity to share some reflections and some poetry.
- May 25 Joy Richards became our new Congregational Administrator, taking over from Chris Chang Weeks who had served in the role from the beginning of the pandemic.
- June 26 We welcomed new members into our congregation: Chris Field, Rob Field, and Ellen Jordan.
- July 20 The Leadership Council decided to expand the scope of Rev. Rachel Knuth's position from half-time to full-time with the title "Associate Minister."
- August 1 Annual Performance Reviews were conducted for staff.
- August 12 The annual Apple Pie Fundraiser returned in a modified but familiar way.

- August 26 We held our first All-Church Camp Weekend at Westminster Woods in Occidental.
- September 4 We blessed the waters of summer which were gathered from around the county and country and world, including heart-shaped stones from the Gualala River.
- September 11 We launched the program year of our church which runs through May 2023.
- October 9 With the theme, "A Future with Hope," we kicked off our annual Pledge Drive in support of the 2023 Local Ministry and Wider Mission of our congregation.
- November 20 We blessed our 10 Confirmation Class participants. 7 of them confirmed their Baptism, joining the church as members: Spencer Allen, Sophia Broadbent-Bell, Eliana Curtis, Elia DelMonte, Tamar Knuth, Owen Thomas, and Reece Thomas.
- November 29 We hired a new custodian, Michael Sadler, to care for our much loved and heavily-used facility.
- December 4 Our Advent theme, "From Generation to Generation," introduced us to the biblical characters of Zechariah, Elizabeth, Miriam, and Yusef and invited us to tell the stories of our faith.
- December 18 We celebrated the re-affirmation of baptism for a transgender person who grew up in our church. There were tears of joy as we released his former name and affirmed his baptism with a new one.

In 2023, I see us building momentum and growing our capacity to learn, lead, and serve. As we continue to emerge from the pandemic, we are discovering that we cannot go back to business as usual.

- We need to learn again, together, what it means to be a people of faith, what it means to cultivate spiritual practices, what it means to trust in God who loves us still.
- We are also learning about leadership, that leadership comes in many forms and that it can be taught and nurtured. Leadership requires courage, vulnerability, and creativity.
- And we are learning to serve. The church does not exist for itself. It exists to be in relationship with God
 and to serve as Christ's body described in this song attributed to Saint Teresa of Ávila (b. 1515 CE):

Christ has no body now but yours,
No hands, no feet on earth but yours,
No eyes with which to look
compassion on this world.
Christ has no body now on earth but yours.

ASSOCIATE MINISTER 2022 REPORT Rev. Rachel Knuth

It was my deep privilege to offer leadership at Community Church in 2022. I wore 3 hats this year!

I began the year with the title "Acting Lead Minister," and was delighted to serve our congregation full-time, as Pastor Benjamin engaged a sabbatical through the spring: Epiphany through Transfiguration, Lent through Holy Week and Easter. During this time I led worship and preached, offered pastoral support, brought in several guest preachers, shared spiritual practices of Lent, helped lead listening circles for our Community Behavioral Covenant, and came alongside the Leadership Council in a new way. I am grateful to all the volunteers who stepped in to be of support and to keep our ministries unfolding in new ways during this time. Evidently Easter 2022 was the first time a woman preached the Easter sermon at our church, how exciting!

I resumed my half-time position as "Associate Minister of Congregational Care" through the summer: through Eastertide and Pentecost in ordinary time. During this phase I continued to offer spiritual care, pastoral home visits, helping to lead worship, and even was called upon as a last-minute substitute chaperone for the Youth Mission Trip to Paradise. There was a Sunday when the power was out, there were Remembrances to write, there were care teams to accompany, and preparations for the revival of a church camp weekend coming up in August.

I rounded out the rest of the year serving as full-time "Associate Minister" from August 1 through the rest of ordinary time, Advent, and Christmastide. In this new-to-me position, I helped lead our newest iteration of the All-Church Camp Weekend, supported Sunday morning children's program Wondering Circle, supported Youth Groups led by faithful volunteers, co-led Confirmation classes with Pastor Benjamin, preached about once a month, led our first-ever intergenerational Pumpkin Party, led the Advent Workshop, led a Reaffirmation of Baptism for one of our transgender church members, led Longest Night worship, as well as Christmas Eve and Christmas morning worship.

Attended the interfaith Transgender Day of Remembrance service at Unitarian Universalist Church of Santa Rosa.

Continued to serve on the volunteer board of the Sebastopol Area Senior Center.

Was a guest speaker in a high school comparative religions class at Sonoma Academy.

Led a Memorial Service for a community member at Armstrong Redwoods.

As mentioned in last year's FC Report, the work of the Facility Committee is a continuous, almost open-ended process that's rarely, if ever, "fully completed!" Having new maintenance issues and new repair tasks seems to be the "new normal" on our church campus and the members of the FC do a remarkable job of keeping-up with the demands, so, before the short review of the work performed in 2022 that follows, I'd like to speak for the whole of our congregation in saying thank you to each member of the Facilities Committee for keeping our church buildings & grounds beautiful and functional . . . you all do an exemplary job!!

The FC meets on a monthly basis and assesses / prioritizes any repair or maintenance projects that arise and, with only a couple of exceptions in 2022, the repair & maintenance projects were performed by committee members and/or volunteer members of our church; performing the repairs or maintenance "in-house" provides a tremendous savings for our church! From electrical fixtures & issues, plumbing fixtures & issues, landscape irrigation issues, painting, repair of lock boxes, spot-patch roof repairs, repairing door hinges and everything in between, below find a very small sampling of the many 2022 projects that were tackled by the FC:

- Driveway retaining wall to the immediate south of Memorial Hall repaired (in-house)
- Spot-patch roof repair over the furnace room / Ceiling dry wall repair in the furnace room (in-house)
- Painting of Pastor Rachel's office & various doors throughout the church campus (in-house)
- Various plumbing & electrical issues repaired / automatic door opener repaired (in-house)
- Exterior dry rot removed and replaced at base of the stained-glass windows behind the Baptismal (in-house)
- Fluorescent lights & fixtures replaced in the nursery school, aka, Casa de Bambini (in-house)
- Roof rehabilitation of the low sloped roofs over the Narthex, Church Offices & Fireside Room (outside contractor)
- Floor replacement in the kitchen of Fellowship Hall (outside contractor)

As we move forward into 2023 the Facilities Committee knows we will experience a variety of issues needing to be remedied as our church buildings & grounds will be another year older and, like our own homes & yards, will have new maintenance & repair needs. Having said that, I'd like to ask you to join us in our maintenance efforts? I know the members of our church have a wealth of experience & knowledge for "fixing things" and I'd like to invite "new participation" on our Facilities Team from our congregation; I know many of you would be great additions to our team! Truly, the comradery, partnerships and friendships that come from working together on our church campus makes our efforts more than worthwhile . . . our work together becomes a gift to each participant! It has been another interesting and busy year. We had our main pastor, Benjamin Broadbent, on sabbatical from February - May. The congregation then voted to move Pastor Rachel Knuth, Associate Minister, from a part-time position to a full-time position and the scope of her job includes Youth Ministries.

During this time, we needed to find a replacement for our Congregational Adminisistrator, Chris Chang Weeks. After several different interviewing attempts, we hired Joy Richards. We also hired a new custodian in November, Michael Sadler. Both Joy and Michael have been an awesome welcoming addition!

WORSHIP & ARTS MINISTRY AREA 2022 REPORT Linda Roa, Council Member for Worship & Arts

The Worship & Arts Ministry includes everything having to do with worship planning, coordinating and support teams. During 2022, we were finally back to in-person services in the sanctuary with the added ability to record and stream our services to people at home. This was particularly helpful for those who were either ill or who did not want to be in person due to lingering COVID issues. It also allows people to view the services at a later date.

Being back in-person required all parts of Worship Ministry be back and functioning. This meant we needed ushers each Sunday, flowers for the altar and other areas, sanctuary décor (banners), a liturgist each Sunday, music each week as well as a "Church Mouse" to straighten and restock supplies in the pews. Also due to our streaming service, we hired high schoolers to be the new tech team. Additionally, we are in need of a coordinator to line up acolytes each Sunday.

With the help of Nancy Shimetz, we re-wrote the guidelines for ushers to conform to our current situation. Then with the additional help of Pastor Benjamin, we conducted two usher training classes so ushers could understand that theirs is a Ministry of the church – welcoming and assisting people during the service and being aware of any safety issues. We plan future usher trainings as ushers are always needed.

As Leadership Council member I have been encouraged and inspired by our new Associate Minister, Rachel Knuth, our youth leaders, OWL instructors, Godly Play (at this time known as Wondering Circle), and Bible study group leaders. In 2023 Faith Formation will continue to work with children and youth with the present leadership and encourage new people, especially parents to help in these leadership positions with those who have served so well this year as mentors. We hope to expand the OWL teachings to reach more grade levels and even adult learning

Youth ministry team has consisted of Bobbie Johanson, Beth Larssen, and Kathy Mathies with Kathy Bell (who is no longer youth leader but support person for the team). They have been meeting twice a month with an integrated calendar with the confirmation class. They had a Sock Hop in October where they collected socks for teens. Confirmation Class met between September 16 - November 13 culminating with Confirmation Sunday, November 20. There were 11 participants in the class.

The youth groups with parents have already begun talks of their SALT trip, Service and Learning Together (Mission Trip). There will be a Parent zoom meeting on January 3 to talk about the SALT trip and to encourage parents to become more involved with the youth groups.

SAFE PARKING

If you are not aware - The Community Church has been providing a safe location for people to park at night for eight years. Individuals seeking a safe place to park were referred by Catholic Charities, Sonoma County's Coordinated Entry System. They were interviewed and if they seemed like a good fit, they become a part of our Safe Parking program. That changed at the beginning of this year. Catholic Charities no longer is involved with Safe Parking. All referrals come from West County Community Services.

Right now we have two registered parkers and space for 3 more. At one point we had a family of 2 adults and 2 children all living in a 4-door sedan. They found housing after a couple of months and moved. For a period of time we had two ladies living in the back of a pick-up. One of the ladies works full time at Whole Foods. They found a home. We currently have a young women that works full time in Bodega Bay. We are providing a safe place for our parkers but they are also providing security for our church. If something unusual takes place on campus, I will receive a call from a parker.

We provide a parking space, bathrooms, and showers. In addition, a volunteer from our church community will drive through the parking lot sometime after 8:30pm. The purpose of the drive through is to help the parkers feel safe and to monitor the lot. No ID is required to receive food, and clients may come every two weeks. Food is allotted depending on the size of the family. The pantry is open MWFS from 10-12AM. It is sustained by a group of volunteers: buyers, stockers, packers, cleaners, people who distribute from the window, the phone staff who make sure that the staff is available and of course the Board of Directors. The pantry is funded through donations from area churches, special donations, and we receive wonderful support from area realtors and the USPS who have food drives which supplement our inventory. and bring in items which we don't ordinarily buy from the main food bank in Santa Rosa. Our church provides the bulk of the funding. We also receive so much wonderful produce from the gardens of members of our church. So thank you to all. FINANCE RESOURCE AREA 2022 REPORT Deidra Warner, Council Officer for Finance (Treasurer)

Thank you to all who served on committees and teams that assisted in the Finance Resource Area. Additional thanks to John Henel, Deanna Euritt, and Pastor Ben who provided extra support to me in this my first year in this position.

There continues to be an impact, albeit lessening, from Covid-19 on the church finances. Additionally, there were several exciting changes within the church that affected the finances, most notably increasing Paster Rachel to full time.

Overall, the state of the church's finances is strong. Complete details of all the financial data can be found else where in the Annual Report.

Here are a few highlights from 2022:

- We received Employee Retention Credits (ERC) that were applied for in 2021 (approximately \$45k) and are expecting to receive additional funds (approximately \$11k) in 2023.
- A portion of the ERC funds (\$29k) was used to reroof the flat roof area of the sanctuary building, allowing
 the facility reserves to be untapped in 2022.
- 2022 ended with a zero cash balance after about \$11k was transferred from reserves in addition to the planned \$24k.
- We continue to have no debts.
- Pledges, our primary source of income for both local and wider church ministries, remain strong.
 Read more in the section reports that follow for additional information in the Finance Resource Area.
